In consideration of WCRC’s approval of the requested “No Treatment Zone” application, the undersigned agrees to accept the responsibility for maintaining the roadside area by cutting of all roadside weeds, brush and trimming low hanging tree limbs before July 15, 2019. The area to be maintained is to be a minimum distance of 14 feet off the traveled portion of the road and 14 feet above the road surface.

As the applicant, I understand and agree that in such event as the roadside weeds, brush and/or tree limbs are not removed from this area by July 15, 2019, WCRC reserves the right to direct the application of herbicide, acting in its sole discretion.

If approved, WCRC agrees to honor this “No Treatment Zone”, subject to the conditions herein. Upon approval, WCRC will stake out your property lines. WCRC will remove the identifying stakes after the spray program has ended for that year.
